Purpose

Florida must subgrant not less than 90 percent of its total ARP ESSER allocation to local educational agencies (LEAs) (including charter schools that are LEAs) to help meet a wide range of needs arising from the coronavirus pandemic, including reopening schools safely, sustaining their safe operation, and addressing students' social, emotional, mental health, and academic needs resulting from the pandemic. The State must allocate these funds to LEAs on the basis of their respective shares of funds received under Title I, Part A of the Elementary and Secondary Education Act of 1965 (ESEA) in fiscal year (FY) 2020.

The purpose of this document is to guide districts to plan for the continued implementation of reopening and recovery through the utilization of the 2021-24 ARP ESSER and to assure federal requirements are met. Florida utilized the 2020-21 District Reopening Plan and the Spring 2021 Education Plan to respond to and mitigate the impact of the emergency and to promote the health, safety, and welfare of persons connected with Florida's educational system.

The Department recognizes that the safe return to in-person instruction must be accompanied by a focus on meeting students' academic, social, emotional, and mental health needs, and by addressing the opportunity gaps that existed before – and were exacerbated by – the pandemic. In this document, districts will describe how they will support the development of high-quality plans for the use of ARP ESSER funds to achieve these objectives for the following student groups: students from low-income families, from each racial or ethnic background, by gender, English Language Learners, students with disabilities, experiencing homelessness, in foster care, migratory students and other student groups.

- 2. Supplies and supervision of enrichment activities, such as after school clubs like drama, chess, band, running, garden, etc. Supplies will include musical instruments, props and script for drama production, tools for garden, etc.
- 3. Summer school program for students in need of credit recovery option materials may include access to E2020 content and teachers to supervise program.
- 4. Reading coach instructional position to improve the quality of instruction with teachers and the academic achievement of students in reading due to learning loss during the pandemic. This position will help us fill the learning gaps created when students missed a substantial amount of in-person instruction during the pandemic.
- 5. Paraprofessionals to support academic needs of struggling students in reading and math, and, to cover classes for quarantined staff. Coverage also needed in the front office and clinic.
- 6. Interventionist instructional position to support students who are identified as not making adequate progress. This position will help us fill the learning gaps created when students missed a substantial amount of in-person instruction during the pandemic.
- 7. Math coach instructional position to improve the quality of instruction with teachers and the academic achievement of students in math due to learning loss during the pandemic. This position will help us fill the learning gaps created when students missed a substantial amount of in-person instruction during the pandemic.
- 8. Intervention support for students during the school day to include targeted small group instruction in reading and math classrooms. Interventions will be provided by classroom teachers working through planning.

- 1. Professional development for teachers in the Marzano Focused Teacher Evaluation Model key components will include two-hour modules for Identifying Critical Content, Standards Based Planning, and Conditions for Learning.
- 2. Collegial coaching for teachers teachers will attend collegial coaches training and will spend time during the school day creating and observing model classrooms. Substitutes may be needed to cover classrooms of our coaches.

- 7. Reading Renaissance (STAR) web-based program focused on progress monitoring in reading and math. This program allows progress monitoring to be completed at school or at home due to students being quarantined.

- 5. Projector for gymnasium due to the pandemic and social distancing, as well as covering classes for staff out due to COVID, our gym has been used as a classroom space multiple times this school year.
- 6. Projector screen for gymnasium due to the pandemic and social distancing, as well as covering classes for staff out due to COVID, our gym has been used as a classroom space multiple times this school year.
- 7. Outdoor sound system to be used at dismissal over 300 students are picked up by their parents at dismissal. Students are spaced out due to COVID restrictions. This outdoor sound system will allow students to hear their name when called for dismissal.
- 8. Portable wireless speaker system for each classroom ensures each student can clearly hear their teacher. Speaker is kept in a central area of the classroom.
- 9. Chromebooks for students to ensure each student has access to a Chromebook, allowing all students to be connected to Google Classroom and Focus Gradebook whether working at school or at home.
- 10. Promethean boards two additional spaces in our building will become workspaces for students.
- 11. Installation of technology (Promethean boards, document cameras, printers, etc.)
- 12. GoGuardian Program allows all teachers to monitor the web sites students are accessing in their classroom.
- 13. Teacher/staff computers ensuring all teachers have current technology, allowing them to teach via Zoom or remotely if necessary due to the pandemic.

1. PBIS Reward – web-based program used by staff to reward positive student and staff behavior.
